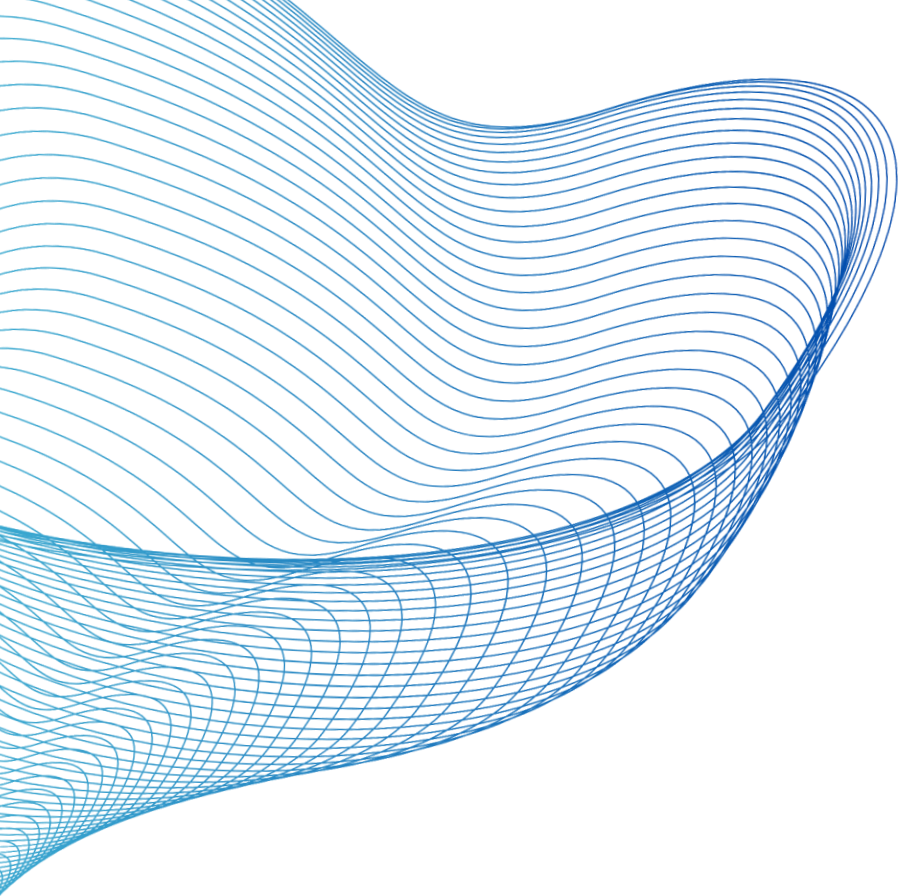


ABOUT OUR FIRM
